## Question: 1

The landfill existed prior to the housing development. The new residents moved to next to landfill, which is now labeled as a nuisance. If the court requires the landfill to close or move, it is entitled to compensation under the conditions established in Spur v. Del Webb.

## Question: 3

**Answer: D**

Explanation:

Impervious surfaces increase storm water runoff which increases water pollution, flooding, and harms water quality. The other answer choices are considered a climate change adaptation or mitigation strategies. Eliminating construction in floodplains reduces the likelihood of flooding as a result of sea level rise. Reducing reliance on fossil fuels improves air quality and the presence of carbon dioxide in the air. Adding green infrastructure strategies reduces storm water runoff and the flow of contaminated water into bodies of water.

### Question: 4

Increasingly, governments are being encouraged to adopt standards ensuring buildings and infrastructure can be used by each person, regardless of their age or mobility limitation. What is the name for this set of standards?

- A. Universal design
- B. Building code

- D. Americans with Disability Act

**Answer: A**

Explanation:

Universal Design is an approach to ensure all aspects of the built environment—buildings and public infrastructure—can be used by any person regardless of their age or ability. Building Codes can incorporate universal design standards, but often do not. Form-based codes are a type of zoning code. The Americans with Disabilities Act requires compliance with ensuring all buildings and public space can be used by anyone using an assistive device. Universal Design is considered to be more holistic than ADA requirements.

### Question: 5

Township, NJ recently built a new school and plans to turn the old school into a condominium complex. What is this an example of?

- A. Brownfield development
- B. Adaptive reuse

- D. Historic preservation

Explanation:

Adaptive Reuse refers to the act of renovating an existing building to serve another purpose. The act of turning historic schools into new housing is a common form of adaptive reuse. Brownfield development is the redevelopment of a formerly contaminated piece of land. Universal Design and Historic Preservation can be incorporated into an Adaptive Reuse project, but their focus is much narrower.

### Question: 6

A household's annual income is \$50,000. The family rents a 3-bedroom single-family house in a highly regarded school district for \$1,500/month. The federal department of Housing and Urban Development would classify the household as what:

The Department of Housing and Urban Development (HUD) identifies someone as cost-burdened if they spend at least 30% of their monthly income on their housing and related expenses (such as utilities). While HUD uses this label, it does not automatically guarantee eligibility for housing subsidies.

The federal surface transportation act passed in 2015 is known as:
