

Explanation:

Change the ConfigurationMode parameter from ApplyOnly to ApplyAndAutocorrect.

The Register-AzureRmAutomationDscNode cmdlet registers an Azure virtual machine as an APS Desired State Configuration (DSC) node in an Azure Automation account.

Scenario: Current Technical Issue

The test servers are configured correctly when first deployed, but they experience configuration drift over time. Azure Automation State Configuration fails to correct the configurations.

Azure Automation State Configuration nodes are registered by using the following command. Register-AzureRmAutomationDscNode

-ResourceGroupName 'TestResourceGroup'

-AutomationAccountName 'LitwareAutomationAccount'

-AzureVMName *\$vmanme* 

-ConfigurationMode 'ApplyOnly'
